Alameda Municipal Power

Electric Bicycle Rebate

After purchasing a new or used **Class 1** or **2** e-bike, you may be eligible for a cash rebate up to \$600!

Am I Eligible?

All AMP residential customers are eligible for the standard rebate amount. Customers enrolled in AMP's **Energy Assistance Program (EAP)** are eligible for the income-qualified rebate.

How do I apply?

AMP recommends using a desktop or laptop. You will complete, sign, and submit your application through the **AMP Rebate Portal** which can be accessed at alamedamp.com/rebates.

Have ready:

- ▶ AMP Account # (found at top right corner of electric utility bill)
- ▶ Copy of sales receipt/invoice showing total cost of e-bike
- ▶ Photos of your e-bike and e-bike serial #

How much is the rebate amount?

Standard Rebate	Income Qualified Rebate
\$100	\$300

How do I receive my rebate?

Once your rebate is approved, it will be electronically delivered from a third party vendor called Prepaid Digital Solutions with the subject line, **Your Alameda Municipal Power Payment Has Arrived!**

It may look phishy, so make sure to check your spam or junk folders for an email from: notification@prepaiddigitalsolutions.com

Important Information:

- Rebate must be submitted within 6 months of purchase date.
- Only 1 rebate per AMP account.
- Only 1 rebate per e-bike purchase.
- **Class 3 e-bikes are not eligible!**

California E-Bike Classification Guide

Class 1:

Low-speed **pedal-assisted** e-bike, equipped with a motor that provides assistance only when rider is pedaling and stops once speed reaches **20 mph**.

Class 2:

Low-speed **throttle-assisted** e-bike, equipped with motors that propel the bike but cannot provide assistance past **20 mph**.

Class 3:

Speed **pedal-assisted** e-bike, equipped with a motor that provides assistance when pedaling and stops once speed reaches **28 mph**. Riders must be 16+ and wear a helmet. These bikes are prohibited from multi-use bike paths unless authorized by local ordinance.

Alameda TMA

The Alameda TMA is offering an additional **\$300 rebate** for eligible TMA members who have submitted and been awarded an AMP e-bike rebate! Visit alamedatma.org/electric-bike-purchase-rebate/ to learn more.

Eligibility:

You must meet the requirements of the AMP Rebate and be a member of the Alameda TMA, a resident or employee in Alameda Point or Northern Waterfront.

- Must submit application within three (3) months receipt.

Electric Bicycle Incentives Program

What We Know

CA's first statewide e-bike incentives program is a \$10 million program to provide vouchers to CA residents to help them afford an e-bike. It is currently being implemented by the California Air Resources Board (CARB).

Program Eligibility

The pilot program is open to Californians living at or below 300% of the federal poverty line.

Incentive Voucher Amount

Base incentive voucher amount is currently **\$1,000**.

- Additional **\$250** incentive for individuals with a household income at or below 225% of FPL, live in a disadvantaged or low-income community.
- Additional **\$750** incentive is available for the purchase of a cargo or adaptive e-bike!

Which e-bikes qualify?

There will be a list of qualifying bike retailers. There will also be a process for e-bike retailers who want to accept e-bike incentive vouchers to apply to participate in the program.

How do I purchase an e-bike with this voucher?

It will be a point-of-sale benefit. Once you pick out a bike from a qualifying retailer, the incentive amount will be applied when you make the purchase meaning you will not have to put out the money up front and get reimbursed through this program.
